DEMOLITION PERMIT APPLICATION GENERAL INFORMATION

A Demolition Permit is required for the removal of an entire building or structure in the City of Weatherford.

Fees: Residential and Accessory Structure Demolition Permit - \$35

Commercial Demolition Permit - \$150

Request to Remove Utilities from Weatherford Electric & Water

***Proof of Ownership (Tax Certificate from the Parker County Appraisal District)

Time Limits: Demolition Permits are valid for one year, however once demolition has begun, you must complete the demolition and removal of all debris within 30 days.

Commercial Structures require an asbestos survey performed in accordance with Texas Asbestos Health Protection Rules (TAHPR) and the National Emission Standards for Hazardous Air Pollutants (NESHAP) prior to a renovation/demolition permit being issued by the City of Weatherford.

****PLEASE NOTE:** that Demolition Permits can not be released until all utilities have been disconnected and removed from structure. If services other than City of Weatherford water or electric are used you are responsible for contacting those companies and making arrangements for disconnection. The other Utility Service Companies contacts are: Texas Gas at 817-594-2722, TXU at 800-242-9113, Tri-County Electric at 817-444-3201.

Residential or Accessory Structures that **do not have utilities** will be allowed to start work two (2) business days from the day this form is submitted to the Planning and Development Department and you receive your permit. This time is allowed to verify there are no utilities and document the structure that is being demolished.

For ALL Structures that **do have utilities**, take the "Request to Remove Utility Service" form to the Customer Service Department at 303 Palo Pinto Street to request the service be disconnected. The Customer Service Department will accept the request and sign the form. You will also need to contact Tx Gas at 817-594-2722 to disconnect gas service and pull their meter. Return the signed form to the Planning and Development Department at 119 Palo Pinto Street. You will be allowed to start work four (4) business days from the day this form is returned back to the Planning and Development Department and you receive your permit. This time is allowed to verify utilities have been disconnected and document the structure that is being demolished.

REQUEST TO REMOVE WEATHERFORD UTILITY SERVICE PRIOR TO DEMOLITION

Demolition Permits can not be released until all utilities have been disconnected and removed from structure. If services other than City of Weatherford water or electric are used you are responsible for contacting those companies and providing proof that all utilities have been removed before permit can be issued.

If you are demolishing a structure that **does have utilities**, take this form to the Customer Service Department at 303 Palo Pinto Street to request the service be disconnected. The Customer Service Department will accept the request and sign the form. You will also need to contact **Tx Gas at 817-594-2722** to disconnect gas service and pull their meter if applicable. Return the signed form to the Planning and Development Department at 119 Palo Pinto Street.

You will be allowed to start work four (4) business days from the day this form is returned back to the Planning and Development Department and the permit is approved. This time is allowed to verify utilities have been disconnected and document the structure that is being demolished.
