

RESOLUTION R2021-01

A RESOLUTION OF THE CITY OF WEATHERFORD, TEXAS, CALLING A GENERAL ELECTION FOR SATURDAY, MAY 1, 2021; ESTABLISHING PROCEDURES FOR THE ELECTION; AUTHORIZING THE MAYOR TO EXECUTE THE NOTICE OF ELECTION; AND AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH THE PARKER COUNTY ELECTIONS ADMINISTRATOR FOR THE ADMINISTRATION OF THE CITY OFFICER GENERAL ELECTION FOR CITY COUNCIL PLACE NUMBERS 3 AND 4.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WEATHERFORD, TEXAS, THAT:

**SECTION 1.
GENERAL ELECTION CALLED/ORDERED**

That the City Council orders a General Election for the purpose of electing City Officers for City Council Place Numbers 3 and 4 and that the election shall be conducted according to the laws of the State of Texas, and shall be held on Saturday, May 1, 2021 from 7:00 a.m. to 7 00 p.m.

**SECTION 2.
NOTICE OF GENERAL ELECTION**

A General Election is to be held on May 1, 2021 for the purpose of electing City Officers for the City of Weatherford City Council Place Numbers 3 and 4.

Early voting by personal appearance will be conducted each weekday at the Parker County Election Administrator’s Office, Parker County Courthouse Annex, 1112 Santa Fe Drive, Weatherford, Texas, between the hours of 8.00 a.m. and 5:00 p.m. beginning on April 19, 2021 and ending April 27, 2021.


**SECTION 6.
